RULES FOR RECEIVING THE RESEARCH/SATHRI SCHOLARSHIP FOR D.TH STUDIES

- 1. The Research/SATHRI Scholarship which is categorized as monthly / full scholarship and bursary/ one time scholarship for D.Th Studies is open to permanent members of the teaching staff of affiliated to the Senate and non-affiliated Colleges and also to candidates sponsored by Colleges and Churches /Institutions, who desire to serve theological Institutions for a long term as a vocation.
- 2. As per the decision of the Research Committee RC/42/2016, the first year students should complete TWO ASSESSMENT Papers with comments from all THREE Supervisors.
- *The applicant should be below the age of 45 years for scholarship.*
- 4. The Scholarship will be awarded as priority to a candidate sponsored by an affiliated College and other bodies stated above with preference to women, tribals, dalits and others belonging to disadvantaged communities.
- 5. The Church to which the candidate belongs should give an undertaking to the Governing Body of the Institution in which he/she is a teacher at present that he/she will be permitted to serve the Institution for not less than five years after receiving the D.Th degree. The Candidate shall sign a bond to serve the Institution for not less than five years after passing the M.Th degree. Similarly, the Institution should also sign a bond that it will employ the candidate for not less than five years after his/her successful completion of the course. These bonds, in duplicate, on Rs 10/- non-judicial stamp must accompany the application for scholarship.
- 6. The applicant shall sign an agreement that all fees which are due to the Department of Research/SATHRI shall be deducted from the scholarship if the same is granted to him or her.
- 7. The Institution sponsoring a candidate for Research/SATHRI scholarship is required to pay Rs 12,000/- (Rs 4000/- per year) towards the scholarship fund of the Research Department/SATHRI before the scholarship is released to their candidates and failing which will lead to the withdrawal of the scholarship.
- 8. Application form should be sent in a prescribed form along with a fee of Rs 1000/- (Rupees One Thousand only) by Online/DD drawn in favour of DEPARTMENT OF RESEARCH/SATHRI payable at Serampore or Kolkata.
- 9. Application form should be properly filled up and sent to the Department of Research/SATHRI with all the necessary documents and failing which may lead to rejection of application.
