ELIGIBILITY CRITERIA FOR D.Th. SUPERVISOR

Doctoral Supervisors (Ref. D. Th. Regulations 2017)

Following persons are considered as competent to supervise doctoral candidate

- I. Those who have earned doctoral degree in a branch of study in which doctorate is offered from a theological institution/university which is recognised by the Senate of Serampore College, and
- II. Those who have published scholarly articles in recognised journals and / or presented scholarly papers at the regional, national and international consultations: at least a minimum of one such article/paper per year, and
- III. Those who have been teaching post-graduates at least for a period of 3 years
- IV. He/she shall not be older than 70 years of age and possesses a good stage of health at the time of assigning a candidate. Any exemption to this shall be under the purview of the committee for research.

The following be considered as resource person and supportive staff.

a) Resource Persons

Doctoral supervisors who have competence in a branch of study other than his/her own branch of specialization are considered as resource persons in that branch of study.

b) Supportive staff

Those persons who have earned doctorate but do not have enough teaching experience and or do not have a required number of scholarly articles to their credit be considered as supportive staff in the branch of their specialization and may assist supervisors in doctoral supervision.

Eligibility of Thesis supervisors who are not full-time Professors in the centres

- a. Supervisors of Dissertation shall be the ones who are approved by the Research Committee.
- b. The Doctoral centres shall send the *curriculum vitae* of the supervisors who are not full-time professors in the centres to the Dean for its approval by the committee.
- c. The Doctoral Research Centres shall also send to the Dean of Research/SATRI a "no objection" letter from the employers of such supervisors.
